IMPACT OF COVID-19 ON HAILEYBURIA TEA ESTATES LIMITED (HTEL)

Due to spread of COVID-19 pandemic and the consequent lockdown restrictions imposed by The Central and The State Government, the Company implemented a complete Lockdown in its all divisions. From 27th March, 2020 to 4th April, 2020 all its 4 divisions namely Chinnar, Semnivalley, Haileyburia and Vallakadavu and factory at Semnivalley Estate were closed.

During this period, the estimated loss of production was 60,192 kg of made CTC dust tea amounting to Rs. 69, 82,272/- approx. calculated at budgeted sale price of Rs 116.00/- per kg.

From 27th April, 2020 to 3rd May, 2020, due to our Elappara village where all our 4 estates & factory is located were closed due to the area converted to Red Zone and a Containment Area on account of some suspected COVID-19 cases.

The estimated loss of production for above mentioned period was 59374 kgs of CTC dust made tea valued to Rs. 68,87,384/- calculated at budgeted sale price of Rs 116.00/- per kg

The company also suffered in terms of adverse effect on leaf standards due to delayed plucking over growing of leaves and inability to carry out Spraying, Manuring, Pruning and other until cultural operations, amount of which cannot be quantified.
